Buying votes

Joe launches a 'College Loan Forgiveness' scam

Joe Biden's latest scheme to buy votes via executive order has appeared in the form of a student loan forgiveness scam, reimbursing or forgiving student loans in payments of \$10,000 and \$20,000. Those dollar amounts, multiplied by the number of outstanding loans, was estimated to total at least \$300 billion in the first ten years.

On August 24, however, a report from *The Committee for a Responsible Federal Budget* titled "New Student Debt Charges Will Cost Half a Trillion Dollars," found that Biden's vote-buying scam "will cost between \$400 billion and \$600 billion over the next ten years, with a central estimate of roughly \$500 billion." That blows the \$300 billion out of the water.

Biden's student loan scam forgives \$10,000 in college debt for those with incomes up to \$125,000 and pays off \$20,000 for Pell Grant recipients. It also extends the federal student loan payment "pause" implemented during covid to December 31.

Adding a new wrinkle concerning that "payment pause," the White House says, "You can get a refund for any payment (including auto-debt payments) you made during the payment pause (that began March 13, 2020). Contact your loan servicer to request that your payment be refunded." THIS is completely nuts, as is the entire discriminating, economically disastrous concept. Instead of a sincere "thank you" for being responsible financially, you can get your money back! Just ask!

The *Education Data Initiative* found in their study of July 21, "Student Loan Debt by Income Level," that "Americans with income higher than the national average owe an estimated 65% of the nation's outstanding student loan debt." So wealthier Americans get a handout and those with less get to foot the bill.

Judging by where the bulk of the outstanding loans are, middle and lower income earners will get screwed. And, despite the statements by Biden that his college debt write-off will not negatively impact inflation or the deficit, it will surely worsen both.

Republican Senator Tom Cotton from Arkansas responded to Biden's vote buying scam on August 24, tweeting: "There is no such thing as student loan forgiveness--this is a bailout, paid for by the large majority of Americans who never went to college or who responsibly paid off their debts."

Even Obamanista Jason Furman, a DNA-deep Democrat, had a problem with Biden's disastrous

plan, tweeting: "Pouring roughly half trillion dollars of gasoline on the inflationary fire that is already burning is reckless. Doing it while going well beyond one campaign promise (\$10K of student loan relief) and breaking another (all proposals paid for) is even worse."

Ironically, it turns out that Joe Biden is one of the *architects* of the college debt crisis. His landmark bankruptcy reform legislation when he was in the Senate helped create the system that makes this extreme amount of debt possible. Thanks to Joe, 44 million borrowers in this country owe roughly \$1.7 trillion in student debt.

Back on January 7, 2020 *The Intercept* ran this: "Joe Biden's role in creating the student debt crisis stretches back to the 1970s." The article explained that "In 1978, Biden supported the 'Middle Income Student Assistance Act,' which eliminated income restrictions on federal loans to expand eligibility to all students." The *Intercept* piece revealed that "Biden helped write a separate bill that year blocking students from seeking bankruptcy protections on those loans after graduation." (Decades later, those same twisted ideological ideas created the home mortgage crash and banking crisis in 2008.)

Government "aid" is what made college and university tuition so expensive. It has done the same damage to health insurance and all else it has sought to "improve" or control. And Biden spent 40 years in the Senate making government bigger and the middle class responsible for paying the cost. His work ended up with the government *federalizing* all student loans. Today, he attempts an economically disastrous remedy through another executive abuse of power.

Biden's plot is blatantly political, to buy votes in the upcoming 2022 midterm elections – a multi-billion dollar bailout. But his action is patently *illegal*, as even House Speaker Nancy Pelosi said earlier this year without using that word that Democrats hate. A president has no executive power to forgive loans. And the federal government should have no power, constitutionally, to make them in the first place.

This latest scam is another detestable, impeachable act. Add it to Joe's growing list.

One year later

One year after the severely botched U.S. withdrawal from Afghanistan, details of the deep incompetence of the Biden Regime are surfacing.

One of the most egregious affronts to our nation by our own leaders were the bold lies told by Biden officials. Here are a few: They planned for all contingencies; only 100 Americans were left in Afghanistan after August 30, 2021; the DOHA Agreement tied Joe Biden's hands; al Qaeda was no longer present in Afghanistan; our allies supported the withdrawal; and senior U.S. military command advised it. All of these mislead us intentionally.

Now Rep. Michael McCaul (R-TX) of the House Foreign Affairs Committee has announced a forthcoming GOP report revealing new details of the worst foreign policy disaster in U.S. history.

There was no plan at all; thousands of Americans remain in Afghanistan; there was *nothing* "tying Biden's hands"; al Qaeda maintained a presence there; and the White House did not listen to advice from the U.S. military, preferring to embrace their rosy expectations for the Taliban. They disregarded intelligence on the ground, leaving tens of thousands of Afghan allies and Americans stranded "behind enemy lines."

McCaul revealed that that the Taliban offered control of Kabul for the duration of the evacuation to CENTCOM commander Gen. Frank McKenzie, whose response was "that's not my assignment." A call to the White House for authorization was not returned. Later, WH Press Secretary Jen Psaki said they "wouldn't have approved that." The State Department was totally inept, no help.

This gross inaction led to a suicide bomber killing thirteen U.S. service members who died at the Taliban-controlled HKIA airport in Kabul on August 26, 2021. And tens of billions of dollars in U.S. military hardware and a strategic airbase are now in enemy hands.

Repeated abuses of power

It appears that the bulk of what the FBI confiscated from Trump's Mar-a-Lago property are documents that he *declassified* while president, as all former presidents have had the power to do without questions, subpoenas, or warrants. Presidents get to decide what is or isn't "classified." Donald Trump has been the exception to this for over six years. *Anything* "Trump" is fair game.

To deal with disparities and dubious legalities created by the FBI when they pilfered his home on August 8, Trump's attorneys have filed a request for a neutral "special master" to review the documents taken during the raid. It appears that a federal judge has approved it, but can we even trust *this*? The FBI has a sordid history of dirty affidavits and fraudulent warrants (FISA?), so naturally they fought release of the affidavit that was filed for the warrant to search Mar-a-Lago. They don't want the public to know the purpose for the raid or the perpetrators, as evidenced by the heavily redacted affidavit just released by court order. But leading up to this latest fraud, the intimidation has been intense and fraught with blatant abuse.

On September 20, 2017 the headline in *The Hill* read, "It looks like Obama did spy on Trump, just as he apparently did to me" In her piece, investigative reporter Sharyl Attkisson wrote, "...the FBI did indeed 'wiretap' the former head of Trump's campaign, Paul Manafort, both before and after Trump was elected." The FBI raided Manafort's home and office. Unable to find anything pertaining to Trump and Russia, they charged him for an old crime, kept him in solitary confinement, then sentenced him to 7½ years in prison, for charges completely unrelated to Trump. They found a man associated with Trump, so there had to be a crime. Their job was to find – or *make* – one. And altering evidence is not out of the question for the FBI and Garland's DOJ.

In 2019, the FBI raided the home of Roger Stone at 6:00 a.m., informing CNN beforehand to cover the break-in. Before Stone's attorney was given a copy of the warrant or even notified of the action, the arrest warrant was leaked to CNN.

FBI agents also raided the offices and homes of attorneys Victoria Toensing, John Eastman, and Rudy Giuliani, searching for any information that could be negative concerning Donald Trump; and Trump campaign officials Carter Page and George Papadopoulos were hit by entrapment.

Trump economic adviser Peter Navarro was arrested at the airport by armed FBI agents, handcuffed and shackled, then carted off to jail, simply for a federal misdemeanor: failing to comply with a congressional subpoena. *Politico* reported on this arrest on July 15, in "Judge questions FBI arrest tactics against Trump adviser Navarro." The Obama judge stated, "It is curious... at a minimum why the government treated Mr. Navarro's arrest the way it did. It is a federal crime, but it is not a violent crime... It is a surprise to me that self-surrender was not offered." The FBI *intent* was to create fear through intimidation and force. Why issue a subpoena when you can send a threatening message with a warrant?

John Solomon, at his site *JusttheNews.com* on August 22, posted "More Whistleblowers come forward against 'out of control' FBI," exposing how the corrupt institution of the FBI had become "completely politicized." In his analysis of FBI abuses, the same names kept showing up. "FBI Detroit chief during bungled Whitmer 'plot' sting now runs DC office that raided Mar-a-Lago," Solomon said, referring to FBI Assistant Director-in-Charge Steven D'Auterono, who oversaw FBI agents embedded in the set-up to kidnap or murder Michigan Governor Gretchen Whitmer. D'Auterono also oversees the January 6 "criminal investigation" and managed the agents who raided Mar-a-Lago.

Another familiar name Solomon raised is Brian Auten, an FBI analyst and vitriolic Trump-hater who was a key figure in the Crossfire Hurricane investigation and worked to discredit the Hunter Biden laptop as "Russian disinformation." He was also a member of the FBI team that raided Mar-a-Lago.

On August 15, for his piece in *Gateway Pundit*, Jim Hoft chose this headline: "Confirmed: At Least 20 Undercover FBI and ATF Were Embedded at Capitol on January 6 Along with Several Undercover Capitol Police Agents."

One Republican senator, Ron Johnson of Wisconsin, is finding agents who are willing to come forward under "whistleblower" protection. Concerning Hunter Biden's laptop, one FBI whistleblower revealed that, "...local FBI leadership told employees, 'You will not look at that Hunter Biden laptop,' and that the FBI is 'not going to change the outcome of the election again.'" (*Again?*)

It has become obvious that the FBI did all they could to protect nominee Biden while those thousands of mail-in ballot drop boxes were filled.
